Mayor John Coombs called the meeting to order. Bishop Willie Joy offered prayer. Mayor Coombs led the chambers in the pledge of allegiance.

City Recorder Allison Baker called the roll: Mayor Coombs present, Vice Mayor Duncan present, Commissioner Bell present, Commissioner Tinnin present, and Commissioner Young present.

Consider minutes of the June 9th, 2016 regular meeting of the Board of Commissioners. Vice Mayor Duncan made a motion to approve the minutes of June 9th as written. Commissioner Tinnin seconded the motion and motion passed 5-0.

City Manager Ellis reminded everyone of the upcoming 4th of July Celebration at Moss-Wright Park.

Fire Chief Ken Reeves provided information on the upcoming fundraiser the Fire Department is hosting for the 30th Annual Kids Christmas. The Fire Department will be selling BBQ, ribs, and pork shoulders on the 4th of July.

Mayor Coombs recognized programs the City offers for the citizens to engage themselves such as the Citizen's Police Academy, Citizen's Leadership Academy, and Leadership Goodlettsville. The inaugural Leadership Goodlettsville program just completed and Mayor Coombs commended City Manager Ellis and City Staff involvement. He thanked City Manager Ellis on the behalf of the Commissioners for an excellent Leadership Goodlettsville.

Consider old business.

Consider Ordinance 16-866, an ordinance to amend the fiscal year 2015-2016 budget in relation to insurance claims and transferring funds to cover legal expenses, second reading. Commissioner Tinnin made a motion to approve Ordinance 16-866. Commissioner Bell seconded the motion. Vote was then taken which resulted in a 5-0 vote.

Consider new business.

Consider Ordinance 16-867, an ordinance to amend the zoning ordinance to include a donation bin as an accessory use of commercial and industrial developments and high density residential projects, first reading. Vice Mayor Duncan made a motion to approve Ordinance 16-867. Commissioner Tinnin seconded the motion. Mayor Coombs asked about a bin at Ace Hardware and if it was included in this

agreement. City Manager Ellis said response to be delayed until ordinance passes or not. Vote was then taken which resulted in a 5-0 vote.

Consider Ordinance 16-868, an ordinance to amend Ordinance 06-674 as amended, the zoning ordinance of the City of Goodlettsville, by amending language relative to accessory structures in Goodlettsville, Tennessee, first reading. Vice Mayor Duncan made a motion to approve Ordinance 16-868. Commissioner Young seconded the motion. Vote was then taken which resulted in a 5-0 vote.

Consider Ordinance 16-869, an ordinance to amend ordinance 06-674 as amended, the zoning ordinance of the City of Goodlettsville, to include conditional use provisions for community gardens in commercial and industrial zoning districts, first reading. Commissioner Tinnin made a motion to approve Ordinance 16-869. Commissioner Young seconded the motion. Vote was then taken which resulted in a 5-0 vote.
