Mayor Coombs called the meeting to order. James Darden offered prayer. Mayor Coombs led the chambers in the pledge of allegiance.

City Recorder Hucks called the roll: Mayor Coombs present, Vice Mayor Birdwell absent, Commissioner Bell present, Commissioner Young present, and Commissioner Duncan present.

Consider minutes of the September 25, 2014 regular meeting of the Board of Commissioners. Commissioner Young made a motion to approve the minutes of September 25th as written. Commissioner Duncan seconded the motion. Vote was then taken and motion passed with a 4-0 vote.

Harry Xanthopoulos of Salt Lick Trail expressed concerns on the rampant use of golf carts in Indian Hills and Twelve Stones neighborhoods.

Police Chief Goodwin recognized the Officers of the Month for September: Les Carlisle and Joe Bardill.

City Manager Ellis presented Eddie Allen with the Employee of the Month award for September.

Consider Ordinance No. 14-822, an ordinance to amend Ordinance 14-814 by adopting property tax rates for the fiscal year July 1, 2014 through June 30, 2015 as certified by the State of Tennessee Comptroller's Office, second reading. Commissioner Young made a motion to approve Ordinance 14-822. Commissioner Bell seconded the motion. Vote was then taken to approve Ordinance 14-822 which resulted in a 4-0 vote.

Consider Resolution No. 14-607, a resolution authorizing the city manager to terminate a contract for Administrative Hearing Officer services. Commissioner Bell made a motion to approve. Commissioner Duncan seconded the motion. Vote was then taken to approve Resolution No. 14-607 which resulted in a 4-0 vote.

Consider Resolution No. 14-608, a resolution authorizing the execution of an Interlocal Agreement with the Metropolitan Government of Nashville and Davidson County as it relates to law enforcement assistance. Commissioner Bell made a motion to approve. Commissioner Duncan seconded the motion. Vote was then taken to approve Resolution No. 14-608 which resulted in a 4-0 vote.
