

MINUTES OF REGULAR MEETING
GOODLETTSVILLE CITY COMMISSION

The meeting was called to order by Mayor Jones. Prayer was offered by Jerry Garrett.

On a motion by Filson, seconded by Long, the minutes of the January 14 regular meeting were approved as written by a vote of 5-0.

Ordinance No. 92-470, an ordinance to amend Title 4, Chapter 4 (Standard Building Code) of the Goodlettsville Municipal Code (Ordinance No. 86-348, as amended) by adding and deleting various provisions. Third reading. The Mayor stated that the City Attorney had requested that this item be deferred one meeting to give him time to study some provisions of the ordinance further.

Ordinance No. 92-471, an ordinance to amend Ordinance No. 70-120, as amended, being an ordinance establishing a schedule of rates to be charged for sewer services to be supplied by the sewer system of the City of Goodlettsville, Tennessee, and establishing rules and regulations for the operation thereof by inserting a new Schedule 3 in Section 1 of said ordinance, being a new schedule of rates as set forth herein. Also, to amend Ordinance No. 90-440 by deleting the rates scheduled to become effective January 1, 1993. This increase is necessary to comply with our contract with Metro for sewer treatment and to maintain rates on the same level as their rates. Third reading. Motion by Driver to pass on third reading. Seconded by Garrett. Passed 5-0.

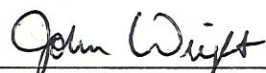
Ordinance No. 93-472, an ordinance to amend Ordinance No. 89-413, as amended, by rezoning a portion of Parcel 8, Sumner County Tax Map 141, from A (Agricultural) to CPUDL (Commercial Planned Unit Development Limited). Second reading. Motion by Long to pass on second reading. Seconded by Filson. Passed 5-0.

The Mayor made the following reappointments of persons whose terms on City Boards had expired on December 31, 1992: Jim Denton to the Beer Board, Linda Franklin to the Park Board, Walter Todd and Johnny Childers to the Goodlettsville Hearing Authority, and William O. Webster, Jr., and Gene E. Tidwell to the Construction Board of Adjustment & Appeals. Motion by Garrett to approve the appointments. Seconded by Filson. Passed 5-0.

Consideration of approval of a capital expenditure for Mansker Fort repairs was deferred.

Debbie Ellis of the Goodlettsville Women's Club presented a plaque to the Mayor in appreciation of the City's sponsorship of the 1992 Rivergate Ramble Run.

The meeting adjourned at 6:41 pm.
